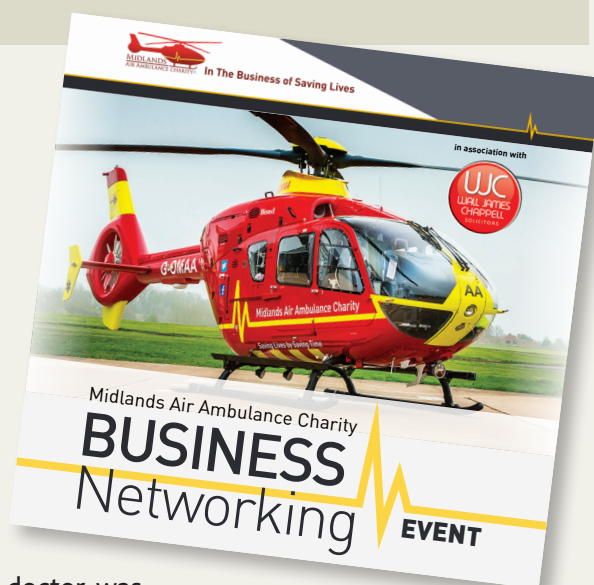

The After Work Club

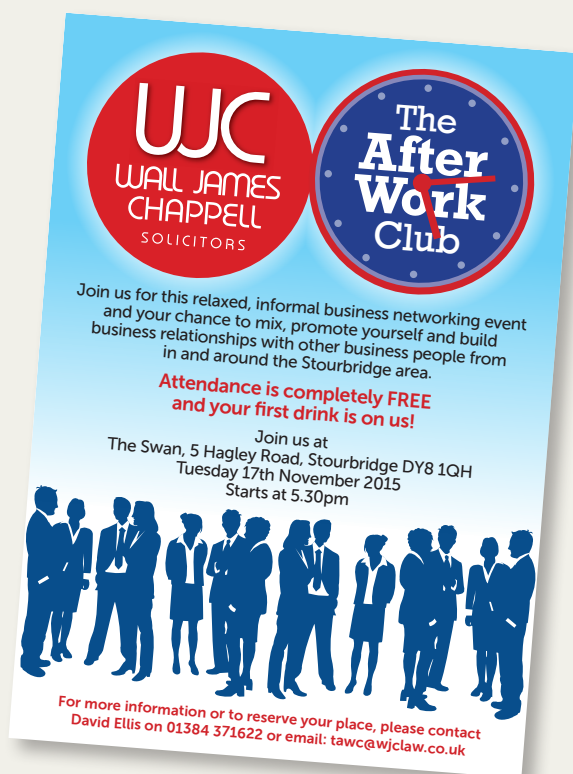
Wall James Chappell is proud to announce the launch of a new networking event in Stourbridge called The After Work Club (TAWC).
